#### **Definitions:**

Society: The society's name which is mentioned in the Memorandum of Association i.e. "Abasaheb Garware Institute of Management Studies' Alumni Association, Sangli, Tal: Miraj, Dist: Sangli (AGIMS's Alumni Association, Sangli)" and which means according to the Maharashtra Public Trusts Act, 1950 / the Societies Registration Act, 1860.

- B) AGIMS's Alumni Association, Sangli: AGIMS's Alumni Association, Sangli means Abasaheb Garware Institute of Management Studies' Alumni Association, Sangli, Tal: Miraj, Dist: Sangli
- C) President: President means the President of AGIMS's Alumni Association, Sangli
- D) Vice-President: Vice-President means the Vice-President AGIMS's Alumni Association, Sangli
- E) Secretary: Secretary means the Secretary of AGIMS's Alumni Association, Sangli
- F) Treasurer: Treasurer means the Treasurer of AGIMS's Alumni Association, Sangli
- G) Member of The Managing Committee: Member of The Managing Committee means the member who is the Member of The Managing Committee of the society i.e. AGIMS'S Alumni Association, Sangli.

- H) Member: Member means member as per Rule 4 & 6 of Rules and Regulations of the society.
- I) Institute: Institute means Abasaheb Garware Institute of Management Studies, Sangli.
- 2) Area of Work (Jurisdiction): Jurisdiction of the society shall be all over State of Maharashtra.
- 3) Financial Year: The financial year of the association shall be 1<sup>st</sup> April to 31<sup>st</sup> March of every year.
- 4) Membership And Procedure To Admit Members:-

The person, who is above 18 years of age and alumni of Abasaheb Garware Institute of Management Studies, Sangli and who agrees and accepts the objects and policies of association, can become member of society. For this, she has to fill annual subscription and admission fee and has to submit membership form which is recommended by two members to the Managing committee. After receipt of such application of membership, it shall be properly scrutinized. After the approval by the majority of the Managing Committee and the approval signatures of the President and the Secretary, the applicant will become member of the society. After approval on this application form, the applicant member gets the rights of member. After acceptance of the membership, the name of admitted member will be noted in the Members' Register, the decision of the Managing Committee is final. In case of rejection of application, the applicant will be intimated the reason of the rejection.

All the members who are present on the date of establishment will be considered as Founder member of the society by the resolution.

The Managing Committee has power to reject the membership application without giving any reason. The person whose membership application is rejected cannot apply again within 2 months or till the next date of the meeting of the Managing Committee. But if the applicant applies again, then the priority will be given to such application.

#### 5) Ceasing to be a Member:

Following are the reasons due to which the Membership will be ceased.

1) The member expires;

- 2) The member gives resignation in writing and which is accepted by the meeting of Managing Committee;
- 3) The member is convicted for the offence which involves criminal act or moral turpitude or commits any act in contravention to the objects and against the interest of the society;
- 4) The member who is declared as undischarged insolvent by the Court;
- 5) The member has not paid annual subscription of the society within the period of 1<sup>st</sup> April to 30<sup>th</sup> April. No correspondence will be made for this;
- 6) The act or omission of the member is against the interest of the society or contravening the rules and regulation which may defame or derogate the dignity of the society or which incur loss to the society.
- 7) By the misappropriation of the funds of the society or by breach of trust.
- 8) By the legal incapacity as per the law to which he is subject

9) By the/physical/mental incapacity declared by a Medical Officer or Doctor. The manber who leaves Indicated goes abroad for more than 6 months. The power to cease the membership is with the general meeting. The membership will be ceased by 3/4 majority of the present members in the general meeting.

### 6. Types of Members

Following are the four types of members of the society.

#### 1. Founder Member -

At the time of establishment of the society, the persons who signed on the Memorandum of Association will be considered as Founder Member. But she has to deposit the following type of membership subscription fee.

#### 2. Life Member -


The alumni who deposits subscription fee of Rs.1,000/- lump sum one time can become Life Member. She has right to attend and vote at the time of election and has right to contest in the election process as a candidate.

### 3. Ordinary Member -

The alumni who deposits annual subscription fee of Rs.100/- per year can become Ordinary member. At the time of admission, the member shall pay Rs.100/- as admission fee and Membership fee, then the membership will remain for one year. Every member has to pay annual fee within the period from 1<sup>st</sup> April to 30<sup>th</sup> April every year. The




membership will be continued only on paying this annual fee. The executive committee has power to cancel the membership in case of nonpayment of this annual fee. She has right to attend and vote at the time of election and has right to contest in the election process as a candidate.

#### Honorable Member -

AGIMS's Alumni Association, Sangli if it deems fit to grant the membership as "Honorable Member" to the persons who are engaged in the noble works in the society or from the retired professors, principals or directors of the institute. They have no rights to contest elections and vote at the time of meeting.

Note: Members as per type no. 1 to 3 can become member as per Rule 4 and provisions of Rule 4 are applicable to them. Member Type No. 1 to 3 have right to contest election of Managing Committee and have right to attend and vote at the time of meeting. Provision of any Subscription Fee is not applicable to Member Type No. 4 i.e. Honorable Member as well as he has no right to contest election of Managing Committee and has no right to vote at the time of election.



- 1) The Annual General Meeting of the society shall be held within 6 months after the expiry of financial year. In any case, the meeting is not held within six months, then the general meeting may be held by 1/3 members of the society and resolutions passed in such meeting shall be binding on the society.
- 2) To approve of the minutes of last meeting, income and expenditure statement, budget put by society.
- 3) To elect Managing committee by majority or by election and to declare result of election.
- 4) To appoint auditor for next year and fixation of his fees.
- 5) To approve the amendments in rules and regulations of the society.
- 6) To discuss about the objects and policies.
- 7) To discuss on any other subject with the permission of President.
- 8) To regulate the works and affairs of the Managing Committee and to review the works of the Managing Committee.

9) To regulate on motions and resolutions in the meeting, to discuss the important subjects of the Society.

#### Notice And Quorum Of General Meeting:-8.

- 1) The meeting shall be held on particular date, at time and venue decided by Managing committee, which shall be mentioned in the notice of the meeting.
- 2) The notice of the Annual General Meeting will be drawn with the signature of the secretary and with the permission of the President and it shall be sent to all members of the society and Director and / or Faculty Member of the institute 15 days before the meeting by hand or by reg. post or by legal electronic media like e-mail.
- 3) In case non receipt of notice by any member which has been sent under certificate of posting, it will not affect the working of the meeting.
- 4) It is recommended but not binding to spread the notice through newspaper.
- 5) The quorum of meeting shall be 3/5 of total members. The meeting adjourned due to insufficient quorum will be held at same venue immediately after expiry of 1/2 hour and in such case, no quorum is required. But such specific instruction shall be mentioned in the notice. With the prior permission of President, invitees can be present in the meeting. But they have no voting right.

#### 9. Special Meetings And Its Functions:-

If the Managing committee is to put any specific important subject before the members or upon written requisition by 1/3 members, a special Meeting will be held within 30 days from the date of receipt of such requisition and at that time all rules of Annual General Meeting shall be followed.

#### Managing Committee and Its Constitution. 10.

The Managing Committee consists of minimum of 7 and maximum of 11 members. The First Managing Committee consists of 7 members. The constitution of Managing Committee will be as follows:

## Tenure of Managing Committee And Procedure Of Election. 11.

The tenure of the Managing Committee will be of THREE years. The managing committee will be elected after every 3 years in Annual General Meeting by majority by show of hands. If necessary, method of voting by poll can be used. The Society can appoint an independent umpire as Election Officer for voting by poll.

### 12. Post of Managing Committee And Their Functions.

## A) President:

- 1) To accept presidential post for all meetings of society and to control the business of the meeting and conduct them in unbiased nature.
- 2) To exercise the casting vote at the time of tie of votes.
- 3) To oversee and control the workings of society as per the rules and regulations of the
- 4) To sign on the documents of the society.
- 5) To give the direction to the secretary for drawing notice of meeting.
- 6) To make contracts in the interest of the society.
- 7) To work as friend, guide and philosopher for the society.
- 8) To make the fiscal transactions on behalf of the society.
- 9) The President is liable for all affairs of the society as a chief of society.

## B) Vice-President:

1) In the absence of the President, to carry out her duties.

## C) Secretary:

- 1) To convene all types of meetings with the permission of the President.
- 2) To draw the notice of the meetings with the permission of the President
- 3) To write the minutes of all meetings of the society and read the minutes at the next
- 4) To carry out the workings of the society under the guidance of the President.
- 5) To manage the correspondence of the society.
- 6) To carry out the workings as per the objects and policies of the society.
- 7) To maintain the accounts and carry out the bank transactions.
- 8) To sue or defend on behalf AGIMS'S Alumni Association, Sangli in the Court.

- 9) To form various committees and sub-committees as per the necessity and dissolve after completion of the works of the committee
- 10) To appoint the employee in case of necessity. To decide the terms and conditions of the service employee. To oversee the works of the employee.
- 11) To obey the instructions of the President.

#### D) Treasurer:

- 1) To maintain documents, books of accounts daily and annually.
- 2) To collect and deposit subscription of members, donations, interests and loans & advances and to pay all bills approved by the President and Managing Committee.
- 3) To put monthly and annual budget before the managing committee.
- 4) The treasurer will be responsible for keeping of books of accounts, bill books, cheque books and pass book.
- 5) For daily expenses, the treasurer can keep Rs.2,000/- cash on behalf of AGIMS' Alumni Association, Sangli with the permission in writing by the President.
- 6) To maintain the updated record of the subscription of members.
- 7) To rectify the lacunae in the records showed by the auditor.
- 8) To collect the subscription from the members
- 9) To deposit the cash in Bank regularly without keeping with har self.
- 10) To accept the subscription, donation, any amount which is legally receivable and issue the printed receipt having the society's name, registration number, and registered address.
- 11) To regulate and control the fiscal situations of the society.
- 12) To make the miscellaneous rules with the permission of the Managing Committee.
- 13) To approve the bills. To oversee the properties of the society.
- 14) To prepare the annual accounts and other financial statements and reports from time to time. To get audited accounts by the auditor. To submit the audit report to the Public Trusts Registration Office, Sangli annually. To submit other reports and returns to the concerned departments.

## E) Members of Managing Committee:

1) To help the office bearers in their daily works.

- 2) To attend and vote at the meetings of Managing Committee and Annual General
- 3) To endeavor to raise the members of the society i.e. AGIMS' Alumni Association,
- 4) To take the information of the last year students of each faculty every year.
- 5) To contact the passed out students of all the faculties in the Institute for membership.
- F) Rights and limitations of the members of the society:
- 1) The member of the society can take part in every program of AGIMS'S Alumni
- 2) If there is misunderstanding between any member and the office bearers or members of managing committee, then the member has right to put her grievance against such members only before the Managing Committee then before Annual General Meeting. If the member against whom the complaint is made is in the Managing Committee, then any other elder Managing Committee Member may be appointed as Mediator for the redressal of the grievances. The Mediator's decision will be full & final. The membership of the member will be ceased without giving any reason in case of grievance such as if she indulges in publishing of the grievance matter in newspaper, convening a public meet, acting against the interest of the society, organizing the march, defaming the institute or the mother institute Women's Education Society, Sangli, indulging in the activity of sabotage in the premises of the institute. Minimum 30% of the members shall support the grievance in writing to put the grievance in annual general meeting. Such grievance shall be submitted 45 days before the Annual General Meeting. The member against whom the complaint is made shall not be ceased as member without giving opportunity of being heard in the annual general meeting.
- 3) All trustees are responsible for the decision of the Managing Committee.
- 4) Without prior permission of / intimation or notice given to Director or any concerned Faculty of the institute, the members of the society cannot organize any program, meeting within the premises of the institute.
- Meeting Of The Managing Committee And Requisition Meeting Of The Managing 13. Committee:-
  - 1) The meeting of the Managing Committee shall be convened twice in the financial year. If necessary, more meetings will be convened.

- 2) The membership of the Managing Committee of the member will be cancelled by resolution passed with majority if such member is absent for consecutive three meetings without permission.
- 3). If the meetings of the Managing Committee are not held according to the rules and regulations, then the meeting of Managing Committee shall be convened by the President in case of a written requisition is made and signed by 1/3 members of the Managing Committee. Such meeting shall be convened within 15 days from the date of the receipt of such requisition. If the President has not convened the meeting then the requisitionists have right to convene the meeting and that time, all rules of the meeting of the Managing Committee shall be followed and such meeting has power of the meeting of the Managing Committee.

#### 14. Quorum For The Requisition Managing Committee And Its Notice:-

- 1) The notice of the Meeting of Managing Committee will be drawn with the signature of the secretary and with the permission of the President and it shall be sent to members and Director and / or Faculty Member of the institute 8 days before the meeting by hand or by registered post or by legal electronic media like e-mail.
- 2) In case non receipt of notice by any member which is sent by registered post, then it will not affect the working of the meeting.
- 3) Decision may be taken through Circular Method if the decision is required to be taken for any urgent subject. But such decision will be considered as accepted or rejected on the basis of majority.
- 4) When the number of members in the Managing Committee is 7 then 5 will be the quorum and when the number of members in the Managing Committee is changed then 1 + half of the number of committee will be the quorum. The meeting adjourned due to insufficient quorum will be held at same venue immediately after expiry of 1/2 hour and in such case, no quorum is required. But it is binding to write such instruction in the meeting notice.

## 15. Rules of Election of Managing Committee:-

The election of the Managing Committee shall be conducted in the annual General Meeting. The Managing Committee shall be elected by the majority by show of hands in the Annual General Meeting. If the situation arise, then the election shall be Heladlan

conducted by announcing the election program and it will be conducted through voting by poll. The Managing Committee will be elected by the present members in the Annual General Meeting through show of hands or voting by poll if necessary. The society can appoint independent umpire as Election Officer for the election process.

## 16. Procedure for Filing Vacancies in Management Committee.

If any post becomes vacant due to death, resignation or by another reason, then such vacancy will be filled by the remaining members in the Managing Committee by majority with the consonance of Rule 4, 6, 10 and 11 and such change report in the prescribed form will be submitted before Hon. Deputy / Assistant Charity Commissioner, Sangli Region, Sangli. The tenure of the member who is filled on the vacant post will be terminated with the termination of the tenure of the Managing Committee.

## Powers and Functions of the Managing Committee:

- 1) The Managing Committee is the controlling authority for all types of works of the society.
- 2) To execute the strategic decisions and daily workings.
- 3) To execute the resolved resolutions in the meeting of the managing committee and annual general meeting.
- 4) To oversee all types of properties of the society, to maintain the register of the Movable and Immovable Property.
- 5) To submit various returns, audit report, and other reports before Trust Registration Office well in time.
- 6) To pass the resolutions in the interest of the society.
- 7) To amend the rules and regulations if necessary.
- 8) To take the cognizance of the grievances and complaints
- 9) To keep control of the accounts, income and expenditure.
- 10) To appoint committees and sub-committees for specific objectives and dissolve them after completion of the objectives.
- 11) To accept or reject the membership application form with due regard.
- 12) To fill the vacancy caused by way of any reason by majority.
- 13) To appoint the employee and to decide his/her terms and conditions.

14) To decide by majority in the interest of the society

- 15) To maintain all types of accounts.
- 16) To grant the honor as Honorable Member to any retiring member or the person who is engaged in the noble work of the society.
- 17) To raise funds for different works.
- 18) The member of the managing committee or the relative of the member in the managing committee cannot hold the office of profit.

#### 18. Source Of Income:

For enhancing the income of the society, donations, income incurred from the cultural programmes, gifts, income incurred from the properties of the society, foreign contribution after compliance of the rules of Foreign Contribution Regulation Act, Government or Semi-Government grants, Members' subscription, etc. will be considered. Donations or help can be accepted on the agreed conditions of the society. It shall be utilized on the objectives of the society. Henceforth, donations, purchased and acquired property are considered as the property of the society.

### 19. Expenses On The Objectives:

Budgetary provision of expenditure on objectives shall be decided in the annual general meeting.

### 20. Provision Regarding Loans And Deposit:

The society can legally borrow the loan. But the loan will be borrowed with the official permission of Hon. Joint Charity Commissioner, Kolhapur.

## 21. Provision Regarding Sale And Purchase Of Immovable Property:

The immovable property can be purchased as the society deems fit. For this, the resolution shall be passed by the majority in the General / Managing Committee Meeting. But in case of any alienation of the property, the official permission shall be taken from Hon. Joint Charity Commissioner, Kolhapur as per Section 36 of Maharashtra Public Trusts Act, 1950.

#### 22. Bank Account:-

The remaining balance amount shall be deposited or invested in the Account of in any Nationalised Bank / Scheduled Co-operative Bank / Post, But it should not be entrusted

with the private person as deposit. The bank transaction of the society shall be operated by the signatures of any two from the office bearers i.e. from President, Secretary or Treasurer.

## 23. Membership Register To Be Kept:

List of members is maintained as per Rule No. 15 Schedule VI of the Societies Registration Rules, 1971. The Schedule VI is hereby attached.

24. Provision For Amendments In Rules And Regulations:

- 1) If any amendment, addition or deletion in the Memorandum of Association or in the Rules and Regulations of the society are suggested by the Managing Committee or members, then it shall be made according to the provisions of Sections 12 and 12 A of the Societies Registration Act, 1860.
- 2) Such amendment shall be approved by 3/5 majority of present members who has voting rights in the Annual General Meeting. But Amendment draft shall be sent along with the notice to each and every member.

## 25. Provision For Change In Name And Objects Of The Society:

In case of amendment in the name or objects of the society or in case of amalgamation, the proper procedure shall be followed according to the provisions of Section 12 and 12A of the Societies Registration Act, 1860.

#### 26. Dissolution:

In case of winding up/dissolution of the society, the proper procedure shall be followed according to the provisions of Section 13 & 14 of the Societies Registration Act, 1860.
